How do I Log In/ Sign In?

You log in at:

https://northu.talentlms.com/

using the email address, user name, and password you created at check-out. If you purchased the program but did not create your account then we can take care of that for you. Please email us at.: Fran.Wainer@NorthSails.com

I created an account, but the screen says my account is inactive or unavailable. What should I do?

Is it possible to view the course on my tablet or phone?

Yes! You can watch LTRR 2020 on your desktop, laptop, tablet or phone. The best way to view it on your tablet or phone is to download the free TalentLMS app. When you get to the login screen, use 'northu' for the domain and enter the user name and password for your account.

Can I download the course and view it when I don't have wifi or cell service?

Offline viewing on your Tablet or Phone is on the way. Talent LMS is working through beta bugs and has promised a release....soon...

How can I give the LTRR training course to someone as a gift?

Two ways you can *Gift* Learn the Racing Rules:

- 1. Purchase On-Line and create a user name and password for your recipient and then pass that info along to the lucky sailor. Be sure to include the URL: northu.talentlms.com as well as the email, user name, and password info.
- 2. Contact North U and they will process the enrollment and send you a certificate with the recipient's login credentials (or North U can send the certificate directly to the lucky sailor).



After I have gone through the course, is it possible to reset all the quiz and test answers back to zero so I can take them again?

Can I share my login credentials with a friend or crew? No, sorry. Our terms of service clearly state that login credentials may be used only by the person who paid and registered for the course. However, we do have a club plan that is available for sharing LTRR 2020 with members of your group.

Can I purchase this course for a group of sailors at my club?

Yes, we have an annual club plan that is available for certain groups of sailors. The club chooses how many licenses they want and then receives a batch of user names and passwords at a discounted rate. The club can give these to its members as it wants. To find out more details and whether your group of sailors is eligible for this plan, send us an email.

Do you offer a money-back guarantee?

Yes. We hope and expect that you will like and learn from LTRR 2020. If you are unhappy with the course, we will give you a full refund.

How long does my subscription to LTRR 2020 last?

Individual licenses are valid for the duration of the current rulebook – through December 31, 2020. During that time you can view and review the material as often as you like. The club plan group licenses are good for one calendar year and must be renewed after that.

How long is the LTRR 2020 course?

If you watch through all segments of the course without pausing or taking any knowledge checks or tests, it will take you about two and a half hours to get through the course. We have divided the material into six modules covering various parts of the rulebook, and each module is broken down into many smaller sections.

What material is covered in the LTRR 2020 course?

The course essentially covers all the right-of-way rules in the 2017-2020 Racing Rules of Sailing. These include the Basic Right-of-Way Rules (rule 10-13), General Limitations (rules 14-17), Mark-Room (rule 18), Room to Pass an Obstruction (rule 19) and Room to Tack at an Obstruction (rule 20). In addition, the final module covers the rules about exoneration and penalties.
